FACILITY RENTAL RATES – January 2024**

It is the policy of the Board of Trustees that CMAP's rental operations are self-supporting. Fees are intended to cover CMAP's overhead costs and support CMAP's mission in the community. Fees may be waived for CMAP-affiliated organizations, or at the discretion of the Chief Executive Officer.

Rental Rates for Suzanne Patterson Building (SPB) (45 Stockton St., Princeton)

First 4 Hours:

- Large Activity Room (63'x43') - \$175 (Monday – Thursday); \$200 (Friday – Sunday)
- Lounge/Conference Room (Room 1 & 2) - \$125
- Classroom 3 (18'x19') - \$75
- Classroom 6 (18'x25') - \$100
- Kitchen - \$60

Additional Hour, Per Room - \$45/hour

Damage Deposit - \$500

Note the Following for Rentals at SPB:

- For organizations and programs serving seniors: No fee required, suggested donation. Contract required.
- For municipal entities: No fee required. Contract Required.



Rental Rates for Nancy S. Klath Center for Lifelong Learning (NSK) (101 Poor Farm Rd., Princeton)

First 4 Hours (Nonprofit; For-Profit Rates):

- Classroom 104 (18'x24') - \$100; \$140 (\$40; \$50 per additional hour)
- Classroom 105 (21'x24') - \$100; \$140 (\$40; \$50 per additional hour)
- Combined 104/105 (40'x24') - \$175; \$225 (\$60; \$75 per additional hour)
- Lecture Hall/Theater Room 106 (25'x24') - \$150; \$225 (\$60; \$75 per additional hour)
- Conference Room 107 (16'x16') - \$70; \$100 (\$30; \$40 per additional hour)
- Participant Lounge - \$150; \$200 (\$60; \$75 per additional hour)
- Kitchen - \$50; \$75 (\$25; \$35 per additional hour)
- Patio - \$125; \$200 (\$50; \$65 per additional hour)

Technology Use Fees – Suzanne Patterson Building & Nancy S. Klath Center

- In Person Program Technology (Smart Boards, LCD Screens, Sound, Hearing Loop) – An additional \$50 fee per reservation for use of classroom technology includes brief introduction and training on equipment prior to event. (Damage Deposit & Additional Costs may be assessed for broken/damaged equipment)
- Hybrid Program Technology – Hybrid programs require an on-site technology assistant from trained PSRC staff at a rate of \$100 up to 2 hours, \$50 per each additional hour.
